- iv. Mortgage Deed of 10% of plots in lieu of Security against the development works duly registered with Tehsildar Fateh Jang vide No.1083/1 dated 29/03/2022.
- v. The scheme has also been entered in the revenue record.

4. You are hereby required to submit the services design of water supply, sewerage/drainage and roads duly vetted by the Agency concerned alongwith approval fees.
